Incident Summary:

The Cybersecurity and Infrastructure Security Agency (CISA) continues to monitor the evolving Coronavirus Disease, also known as COVID-19, situation closely. CISA is taking part in interagency and industry coordination calls and working with critical infrastructure partners to prepare for possible disruptions to critical infrastructure that may stem from widespread illness.

FEMA reports approximately 6,931,000 (+ 131,287) cases and 400,857 (+ 3,469) deaths worldwide. In the U.S. there are approximately 1,956,710 (+17,887) cases and 111,183 (+808) deaths.

Former Arizona Health Director says the state may need a new stay at home order due to a rise in COVID-19 cases. The Arizona stay at home order lifted on May 15th.

Washington, D.C., National Guard troops have tested positive after being deployed to the city to respond to the civil unrest.

The CDC is closely monitoring the ongoing large gatherings and protests for any spikes in COVID cases.

ACTIVATIONS AND DECLARATIONS

57 Major Disaster Declarations approved; all State / Territory EOCs activated.

Eight states / territories have stay at home orders in place; 34 states/territories have lifted their stay at home orders, though may have other movement restrictions; four states lifted state-wide orders, but maintain regional stay at home orders; three have not issued state-wide stay at home orders and have lifted all regional orders; and seven states never enacted stay at home orders.

The Minnesota Governor's office announced Phase 3 of its "Stay Safe MN plan," which will allow restaurant indoor dining, fitness centers, swimming pools, and entertainment venues to reopen at a limited capacity on 10 Jun. Places of worship, salons, and barbershops will also be allowed to increase their capacity to 50 percent.

The Ohio Governor's office announced Phase 2 will begin 10 Jun. This includes the opening of museums, zoos, indoor athletic facilities, movie theaters, and other tourist and entertainment venues. On 19 Jun, casinos, amusement parks, and water parks will be permitted to reopen.
